

### Conditions:

1. The school is registered and recognition is renewed by the provisions of the Right of Children to Free and compulsory Education Act, 2009 and the Karnataka Education act -1983 The grant of recognition is available initially for classes I to VIII standard and to be extended for Secondary /Senior Secondary classes subsequently in due course of time.
  2. The School shall function in accordance with the Karnataka education act 1986 and by the provisions of the Right to Children to free and compulsory education act 2009.
  3. The school shall admit in pre-school / class I to the extent of 25% of the strength in each class, children belonging to Weaker Section and Disadvantaged Group in the neighborhood and provide free and compulsory elementary education till its completion.
  4. Government shall release the fee fixed towards children admitted under RTE and no fee collected by the school from the students admitted under RTE.
  5. The school shall admit in pre-school / class I to the extent of ..... (%) of the strength in each class, children belonging to Weaker Section and Disadvantaged Group in the neighborhood and provide free and compulsory elementary education till its completion.
  6. The school shall publicize the fee structure in accordance with the government circular no ED31PGC2019 dt:27-07-2019. No extra fees shall be collected other than the fixed fees.
  7. The school shall admit the children only during the periods specified by the government.
  8. The school shall not deny admission to any child, -
    - I. For lack of age proof
    - II. On the ground of religion, caste or race, place of birth or any of them.
    - III. if such admission is sought subsequent to the extended period prescribed for admissions



9. All safety measures in accordance with RTE shall be in place.
10. The school shall ensure that,-
  - I. No child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school.
  - II. No child shall be subjected to physical punishment or mental harassment.
  - III. No child is required to pass any board examination till the completion of elementary education.
  - IV. Certificates will be issued to the children on completing primary education in accordance with the RTE rule 21 and Karnataka education act.
  - V. Inclusion of students with disabilities/special need as per provision of the RTE
  - VI. The teachers are recruited with minimum qualifications as laid under RTE and Karnataka education act.
  - VII. The salaries and allowances paid to the teachers should be in accordance with policy of the state government. (ESI, PF etc.,) and the same shall be paid through bank.
  - VIII. The teachers perform his duties specified under 24(1) and RTE and Karnataka education act rule 17
11. The school shall follow the syllabus on the basis of curriculum laid down by appropriate authority.
12. The school shall maintain the standards and norms as specified in section 19 of Karnataka education act.
13. The school shall function in accordance with section 19 appointment shall be made in accordance with the Karnataka education act.
14. No unrecognized classes shall run within the premises of the school or outside in the name of school.
15. The School facilities should not be used during day or night for any commercial activities and for political purpose.
16. The school is not run for profit to any individual, group or association of individuals or any other persons.
17. The accounts should be audited and certified by a Chartered Accountant and proper accounts statements should be prepared.
18. The School shall follow Kannada language policy 2016
19. The managing committee and the teachers shall work in accordance with RTE and Karnataka education act.
20. School/Managing committee shall follow the rules and regulations of the government and the department.
21. The school shall upload the annual information in SATS by March end every year.
22. If any of the above conditions are not met in accordance with RTE 2019 and Karnataka education act 1993 the recognition will be cancelled.
